


Media Distribution: Arlington Community Access Corporation (DBA Arlington Independent Media, AIM) distributes independent media via multiple avenues, including a content-rich website, two cable channels delivered direct to every subscriber in Arlington (Comcast channel 69 and Verizon channel 38), and an LPFM community radio station, WERA 96.7 FM. Both AIM TV and WERA radio programming stream online, taking content to a global audience. Programs are created by local volunteer producers and reflect a wide range of passions and community concerns.

Media Production Facilities: Arlington Community Access Corporation (DBA Arlington Independent Media, AIM) fully equips media production facilities, such as TV recording studios, control rooms, audio production suite, live radio broadcast booths, and classrooms for hands-on instruction in all stages of digital media production and editing. Facilities play host to county arts and local business district programming, enabling the community to partake in programs not otherwise accessible.
